Girls With Disabilities Gain More Than Skills

Mockery and teasing over her lack of growth yet her siblings in lower classes were bigger and taller are some of the reasons that forced Sidora to drop out of school as early as P4. She chose to stay at home and do house chores until she was invited to participate in the apprenticeship program designed to equip Girls with Disabilities practical skills in tailoring and hairdressing by Kasese District Women with Disabilities Association. With overflowing confidence in self and skills in hairdressing, Sidora hopes to start up her own salon as her client base has widened and faces no discrimination.

Jackline (not real name), a survivor of Gender Based Violence also took part and gained skills in tailoring. A school dropout and teen mother at 17 years, Jackline shared that she made a sell of 60,000/= last Christmas and was glad for the training as it has made it possible for her to be financially independent.

Raising Awareness on Gender Based Violence

Trained facilitators were acquired to enlighten a total of 230 Girls and Women with disabilities in the districts of Koboko and Pader on the everlasting effects of Gender Based Violence against vulnerable groups. Visual pictures and audio

information translated to local languages were the materials used to equip girls and women with disabilities knowledge about GBV, the referral systems in place in case of domestic violence and individual empowerment to demand

for rights when it comes to accessing Judicial services. Violence against girls and women with disabilities is far more extensive in Uganda than violence against the general female population.

Paralegals Supporting Girls and Women with Disabilities

Community based volunteers knowledgeable counseling were recruited to advocate for disability awareness within their communities and support girls and women with disabilities. They worked hard to earn their trust and are the ones who guide them when it comes to seeking judicial help in times of Gender Based

Violence from their spouses.

Rosaline, a 35 year old with a physical disability reported that on the 17th /4/2015, her husband returned home at 10.20 p.m drunk and found her sleeping. He rudely woke her up to serve him food then got angry and started abusing her. In her attempt to escape, she fell and dislocated her

crippled leg. Rosaline then sent for her parents who took her to report to the paralegal who in turn reported the violence to the area Local Council.

Robert fled the scene but was later apprehended by Police who organized a meeting between the parents, LC 1 and the paralegal. Robert was asked to refund the 35000/= her parents had spent on her treatment and fined a goat for his actions. He promised never to abuse her and since then; they are at peace.

Changing The Lives of Girls And Women With Disabilities

Girls and Women with Disabilities were given the tools for sustainability through economic empowerment training in savings and financial management.

Kereen, a physically disabled 45 year old woman from Nebbi district was married to Mr. Ucaki Peter who abandoned her and their children.

She was invited to the training where

financial management skills like savings, group formation for the attainment of funds from banks acted as the stepping stones for financial stability. Kereen said the group not only helped

her in starting up a small scale business but made borrowing money to pay for younger children's' fees easy.

Before the training, Kereen was helpless as her husband left her with 7 children whose welfare she couldn't maintain due to unemployment. Together with her children; Kereen has managed to set up a thriving farm to support their livelihood.

Yenyparwoth is an 18 year old school drop-out from Nebbi district. She was brought out of fear and shame to interact with fellow girls with disabilities during a skills training in tailoring and a village savings scheme which helped kick start her small business in selling roasted groundnuts, maize and vegetables.

Yenyparwoth admitted that shyness, teasing from fellow students and low

self-esteem led to her dropping out of school. She was entirely dependent on her parents until the skills training which has enabled her to live independently as she has her own money, goats and gardens. The financial independence has given her much more happiness than she could have imagined as a girl with a disability.

Advocating for Inclusion of Girls & Women with Disabilities in the National Sexual Reproductive Health Rights Policy

National Union of Women with Disabilities of Uganda's (NUWODU) current program on Sexual Reproductive Health Rights Services (SRHRS) for Girls and Women with Disabilities raised an alarm when NUWODU discovered that the national policy didn't cater for Girls and Women with Disabilities and was not in line with the Ministry of Health and World Health Organization guidelines.

This propelled NUWODU to take action and research into the policy was made to ensure that girls and women with disabilities had full access to

their SRHRS. With the lead researcher Dr. Otim Charles at the helm; NUWODU joined hands with stakeholders from Ministry of Health, Woman MP Representatives and reviewed the old policy in a national dissemination meeting.

Stakeholders pledged to document gaps within other existing policies and present them to relevant ministries to guide policy reviews for effective implementation.

Experiences of Women with Disabilities in Accessing Sexual Reproductive Health Services

During training on Rights Awareness in Sexual Reproductive Health Rights and Services; a woman with a disability shared her experience on how she was denied services because of her disability.

Lillian (not real name) was sent to deliver on the veranda by a health worker while abled expecting mothers were left inside the health center. She said that, her husband joined her on the veranda until she delivered. Lillian further revealed a different incident where she took her other child to hospital and the health worker refused to treat her. Overwhelmed with the weight of rejection, Lillian decided to report the health worker to the Sub-county chief where she was summoned. This worsened the situation in that Lillian is forced to go to a clinic and pay for services

she cannot afford as the health worker refuses to treat her and her child whenever she goes to the health centre.

I attended the first ever mentorship workshop on taking on leadership roles in 2014. I gained skills in leadership from the workshop which I later applied into practice and emerged as a student guild leader for students with disabilities at the institution and their representative in the Student's guild council for the academic year 2015/2016.

there came a need to undergo internship, with the attempt to apply classroom material into practice and without delay, I received a placement in NUWODU. The training environment was excellent. I gained distinguished
